



# 2024-2025 Student Health Insurance Plan: Seton Hall University



## Who can enroll?

All graduate students enrolled in nine or more credit hours are required to purchase the University sponsored health insurance plan, unless proof of comparable coverage is provided.

All law students who are registered for nine or more credit hours are automatically enrolled in this insurance plan at registration and the premium contribution amount for coverage is added to their tuition billing unless proof of comparable coverage is furnished.

All international students, regardless of number of credit hours in which enrolled, are automatically enrolled in the University Sponsored Health insurance plan and the premium contribution amount for coverage is added to their tuition billing, unless proof of other insurance that meets the University's requirements is provided.

The student (Named Insured, as defined in the Certificate) must actively attend classes for at least the first 31 days after the date for which coverage is purchased. Home study, correspondence, and online courses do not fulfill the eligibility requirements that the student actively attend classes. The Company maintains its right to investigate eligibility or student status and attendance records to verify that the Policy eligibility requirements have been met. If and whenever the Company discovers that the Policy eligibility requirements have not been met, its only obligation is refund of premium contribution amounts.
